

HUGO BOSS TEKSTİL SANAYİİ LİMİTED ŞİRKETİ
DISCLOSURE STATEMENT FOR VISITORS
ON THE PROTECTION OF PERSONAL DATA

1. The Identity of the Data Controller

As HUGO BOSS TEKSTİL SANAYİİ LİMİTED ŞİRKETİ (the "**Company**"), registered at Izmir Trade Registry Office with registration number 88253 and carrying out business at the address Zafer SB Mahallesi Boss Sokak No. 10 Ege Serbest Bölgesi Gazimir, Izmir, we, in our capacity as the data controller, provide the following issues for your information within the scope of our disclosure obligation in order to ensure us to act in accordance with the Law no. 6698 on the Protection of Personal Data ("**Law**") for the personal data we obtain from our visitors.

2. The purpose of Data Processing

Due to the fact that you have visited our Company, your personal data, including your identification details, communication data, professional data, vehicle data and visual data generated by the closed circuit camera recording systems in our factory are processed for security purposes.

Within the scope of the Company security or in the framework of proving such situation in case the employee reports are submitted by you, your identity data, contact data and signature data can be processed.

In addition, your log records may be processed on a limited basis for the purpose of providing internal wireless network services and recording access pages within the scope of Company's legal obligations.

In addition, your personal data mentioned above may be transferred to the physical archives and information systems of the Company and kept in both digital and physical environment.

3. To Whom and for What Purposes the Processed Personal May Be Transferred

Your personal data collected may be transferred to the companies providing information technology services and that perform maintenance and repair services for camera systems and to Ege Serbest Bölge A.Ş. and to the Police Department provided it is limited to the purposes described in Article 2 of this Disclosure Statement and to the reasons requiring their transfer within the scope of the Law and related regulations.

4. The Method and Legal Reason of Collection of Personal Data

Your personal data may be processed and transferred by or through the Company, by automatic or non-automatic means, for the purposes stated in Articles 2 and 3 of this Disclosure Statement within the framework of the legitimate interest of the data controller and for the fulfillment of its legal obligation as stated in Articles 5 and 6 of the Law.

Your identity, communication and visual data are collected by automatic or non-automatic means, from the information provided orally or in writing by directly you during your factory

visit and through the camera recordings recorded within the Company and the registration form provided at the Company entrance, for legal reasons regarding the fulfillment of the purposes set forth in Article 2 of this Disclosure Statement.

5. The Rights of Data Subject

Pursuant to Article 11 of the Law, visitors whose personal data is processed may apply to the Company and make requests for the following:

- To learn whether his personal data are processed or not;
- To request information if their personal data are processed;
- To learn the purpose of data processing and whether this data is used for intended purposes;
- To know the third parties to whom their personal data is transferred at home or abroad;
- To request the rectification of the incomplete or inaccurate data, if any;
- To request the erasure or destruction of their personal data if the reasons requiring the processing of the personal data are no longer applicable;
- To request the notification of such circumstances or correction to third parties to whom the personal data has been transferred;
- To object to the processing, exclusively by automatic means, of their personal data, which leads to an unfavorable consequence for the data subject;
- To request compensation for the damage arising from the unlawful processing of their personal data.

You can submit your requests related to your above-mentioned rights to the Company by completing the "Personal Data Subject Application Form", available at <https://www.kvkk.info.tr/clients/hugoboss>, and by using one of the following means:

- In person upon verification of your identity at the address Zafer SB Mahallesi Boss Sokak No: 10 Ege Serbest Bölgesi Gaziemir/Izmir, or
- Via e-mail to the Company's e-mail address hugoboss.izmirkvkk@hs03.kep.tr by using your registered e-mail (KEP) address, secure electronic signature, mobile signature, or your e-mail address that has been previously notified to the data controller and that is recorded in the data controller's system.

Your applications will be concluded in accordance with Article 13 of the Law as soon as possible and within thirty days at the latest depending on the nature of your request.
